- Bidders are required to; together with their bids; submit original and valid **B-BBEE Status Level Verification Certificate** or Certified copies thereof to substantiate their B-BBEE rating claims with **SANAS Logo OR B-BBEE affidavit**.
- **Only locally produced goods and services that meet the minimum threshold for local production and content as determined by DTI will be considered for acceptance. Any Bid that does not meet the minimum threshold is an unacceptable Bid.**
