### **Paving parking area and carports shades**

1. Removal of sand over a distance of 372 m<sup>2</sup> with depth or height of 200 mm.
2. Prepared an area of 465m<sup>2</sup> filled it up with crushersand of 120 mm and packed it out with paving of 80 mm thick over a distance of 372m<sup>2</sup>.
3. Bring m 6\* Carports with the following measurements which also includes nets. No trees should be removed it should be used in between.

  - 2 \* 6, 700 m<sup>2</sup> Length  
2,000 m Height  
5,600 m Across
  - 4\*7,600 m Length  
2,000 m Height  
5,600 m Across
5. Remove the existing paving and repacking thereof over a distance of 3,000 m and 1, 5 m width.
6. The moving of an existing lamp pole over a distance of 0,500 m.
7. The cutting of branches and the removal thereof.
