Pre-qualifications Criteria

All bidding companies are to comply with the following minimum requirements:

1. At least 3 years experience in hosting festivals attended by 3000 to 10 000 people.
2. Submission of reference of previous work done.
3. Ability to raise 70% of budget required for the event to be hosted.
4. The appointed service provider will be expected to submit a budget breakdown of the entire event

- Price(s) quoted must be firm and inclusive of VAT
- Bidders must attach quotation with a letter head of the company when submitting bids.
- A firm delivery period must be indicated.
- This quotation will be evaluated in terms of the 80/20 preference point system in terms of the Supply Chain Management Policy, and for this purpose the **MBD1, MBD2, MBD3.1, MBD4, MBD6.1, MBD8 & MBD9** can be downloaded from LDM

website (www.lejwe.co.za) or collected from the SCM Unit, and be scrutinized, completed and submitted together with your quotation.

- Bidders must submit CK 1 or 2 or any form of registration with CPIC
- **Original Tax Clearance Certificate** or **Tax Clearance Certificates of All Partners** (in the case of a joint venture) must be submitted.
- Bidders must be registered on municipal **Database of suppliers**.
- Bidders must submit their latest Municipal account with the address corresponding to the company's address on CPIC registration document or a Lease Agreement
- Bidders are required to, together with their bids; submit original and valid **B-BBEE Status Level Verification Certificate** or Certified copies thereof to substantiate their B-BBEE rating claims with **SANAS Logo, for Exempted Micro Enterprise** must submit a Certificate issued by registered auditors or accounting officers with practice number.

**NB: No quotations will be considered from the person in the service of the state.
No late quotations will be considered.**

Proposals will be opened in public on the determined closing date in the front entrance of Lejweleputswa District Municipality, Welkom.
